According to Pennsylvania Law, nonpublic school children are entitled to transportation to nonpublic schools as follows:

1. A district which provides transportation for resident public school students must also make identical provisions for the transportation of resident nonpublic school students according to the nonpublic school calendar.
2. Transportation for nonpublic school students must be provided to and from the nonpublic school in which the student is enrolled, even if the nonpublic school is located outside the district so long as the distance is not more than 10 miles beyond the district boundaries. (Note: This distance may be in excess of 10 miles from student's home.)
3. A district may transport children who live along hazardous routes even though the children live within walking distance of the school.

If you think you are eligible for transportation and desire it for the next school year, please complete the request form below and return it to your child's school as soon as possible.

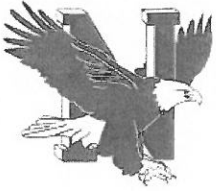

The **Lehigh Valley Charter High School for the Arts (LVCHSA)** student transportation assignments will be emailed this summer. They will reflect the bus assignment for your student to ride from his/her bus stop to Nazareth High School where they transfer to the LVCHSA Shuttle Bus. That bus assignment is for all days that both Nazareth and LVCHSA have school.

Periodically throughout the school year, there are days when Nazareth is closed and Lehigh Valley Charter High School for the Arts has school. On these days, A.M. transportation will be provided only to those LVCHSA students who request it.

If your LVCHSA student wants to be bused to school on days LVCHSA has school and Nazareth public schools are closed, please fill out the "Nazareth Not In Session" Transportation Request below. The deadline for the return of this request is **Friday, July 26, 2019**.

Any student who does not return this "Nazareth Not in Session" transportation request by **Friday, July 26, 2019**, will have to provide their own A.M. transportation to LVCHSA on the days Nazareth public schools are closed.

All students who request and return this "Nazareth Not in Session" transportation form will be notified with their busing arrangement for these special days (i.e., bus#, bus stop location and pick up time).

Please Note: This is for **A.M. TRANSPORTATION ONLY**. All Lehigh Valley Charter High School for the Arts students have access to P.M. transportation services with or without this request.
